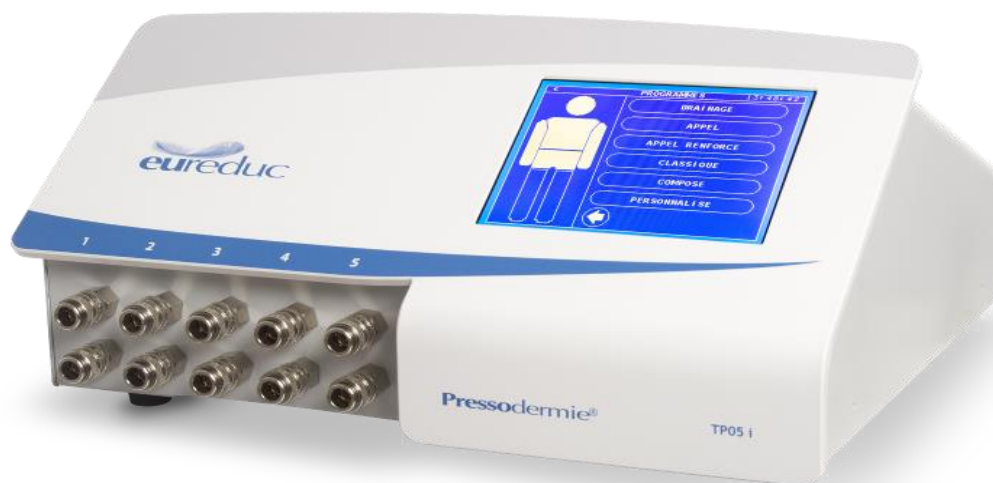

Indications
